SAFETY RULES AND GUIDELINES:

SPECIAL NOTE: PARADE BEGINS AT 10am – Downtown Houston ON SATURDAY, June 13, 2009

1. All Vehicles must present proof of insurance for each vehicle registered in the parade. (due with participation form).
2. Parade officials will inspect all entries and reserve the right to eliminate any entry that is in violation of these rules.
3. For safety reasons, no pedestrians will participate in the Grand Entry parade in Humble.
4. Once your entry has started along the parade route, no one may join the entry.
5. Passes for all participants and staging instructions will be mailed or distributed before or on the day of the event. (Only participants will be allowed passes. All others will require a ticket to gain entry into the event. *Special discount tickets are available for groups of 20+.*)
6. Your entry may not exit the parade route before the end of the parade.
7. No alcohol is allowed.
8. Entries with children under the age of 19 must have one (1) adult per five (5) children. A list of supervising adults' names and telephone numbers must accompany this entry form.
9. All entries must have clear identification signage.
10. Changes in the parade line-up the day of the parade will be at the sole discretion of the parade officials.
